ARTICLES OF INCORPORATION
OF
NEW IDENTITY, INC.

The undersigned, acting as incorporator of NEW IDENTITY, INC., a Corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is NEW IDENTITY, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the Corporation is organized are the transaction of any or all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act and as such may be amended.

FOURTH: The aggregate number of shares which the Corporation shall have authority to issue is fifteen thousand (15,000) shares of common stock, one vote per share of a par value of \$1.00 per share, an aggregate total capital of FIFTEEN THOUSAND AND NO/100 DOLLARS (15,000).

FIFTH: Provisions denying pre-emptive rights are: There are no pre-emptive rights.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: The By-Laws shall set the number of and qualifications of Directors and Officers and shall set forth any restrictions, if any, on the transfer of shares.
