



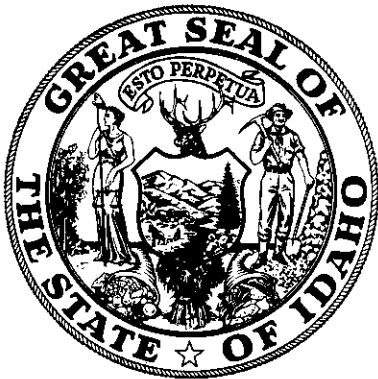
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION  
OF  
PICCOLO, INC.

The undersigned, acting as incorporator under the provisions of the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

1. NAME. The name of the corporation is:

PICCOLO, INC.

2. DURATION. The period of its duration is perpetual.

3. PURPOSES. The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

4. STOCK. The corporation shall have the authority to issue 50,000 shares of capital stock, all of one (1) class, ONE & 00/100 DOLLAR (\$1.00) par value.


They shall serve as directors until the first annual meeting of shareholders or until their successors have been elected and qualified.


