KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, being a natural person of legal age and a citizen of the United States of America, in order to form a corporation for the purposes hereinafter stated, pursuant to the laws of the State of Idaho, do hereby certify as follows:

I.

Name

The name of the corporation shall be "Cee Vee Corporation".

II.

Registered Office

The location and post office address of the registered office of the corporation shall be Route #1, Box 143, King Hill, Idaho 83633.

III.

Registered Agent

The name of the registered agent of the corporation is Charles C. Kast.

IV.

Duration

The period of existence and duration of the corporation shall be perpetual.

V.

Corporate Purpose

Directors

corporation is owned by the corporation, and no act of the corporation, shall be in any way affected or invalidated by the fact that any of the directors of the corporation are pecuniarily or otherwise interested in, or are directors or other officers of corporation; any such indivividually, or any firm of which such director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of the corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors; and the director of the corporation who is also so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of the corporation which shall authorize such contract or transaction, with like force and effect as if he directors or officer of such such other not corporation, or not so interested.
