ARTICLE ONE **NAME**

The name of the corporation is DESTINATION CALDWELL, INC.

ARTICLE TWO **PURPOSE**

The corporation is organized for the non-profit purposes of educating the residents and visitors to the City of Caldwell and surrounding area about the diverse culture, educational, scientific, civic, and athletic attractions and events available to the public in Caldwell and the surrounding area; lessening the burdens of government by providing information, advice, and assistance to the residents of, and visitors to, the City of Caldwell and surrounding area regarding issues related to tourism, including directions, transportation, and safety; enhancing the visitor and resident experience in the City of Caldwell and surrounding area through activities consistent with

charitable purposes including educational programs, research, conferences, seminars, and other dissemination of information related to tourism, tourism economics, and destination development.

ARTICLE THREE NON-PROFIT PURPOSE

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code including the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE FOUR PROHIBITED ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes described in section 501(c)(3). No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or (b) by a corporation, contributions to which

are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE FIVE DURATION

The period of the duration of this corporation is perpetual.

ARTICLE SIX MEMBERS

The corporation shall have no members.

ARTICLE SEVEN REGISTERED OFFICE AND AGENT
