The undersigned, acting as the incorporator of a nonprofit corporation ("Corporation") organized under and pursuant to the Idaho Nonprofit Corporation Act, Chapter 3, Title 30, Idaho Code ("Act"), adopts the following articles of incorporation to the Secretary of State.

ARTICLE I  
NAME

The name of the corporation shall be "Lusk District Neighborhood Association, Inc." (hereinafter, the "Association").

ARTICLE II  
OFFICE

The street address of the registered office is 917 Lusk St, Boise ID 83706 and the registered agent at such address is Eileen Langan Barber.

ARTICLE III  
PURPOSES

The Association is organized and will be operated to: A) provide an open process by which all members of the association may involve themselves in the affairs of the neighborhood; and B) identify the physical and social needs of the neighborhood; and C) identify ways to meet those needs, including seeking funding sources and programs; and D) educate members about issues affecting neighborhoods; and E) engage the neighborhood in the planning and development process; and F) provide an opportunity for the people of the neighborhood to participate in the decision-making processes of the agencies that impact neighborhoods.

ARTICLE IV  
STRUCTURAL ORGANIZATION

This Association shall be composed of a Board of Directors and its officers, and a general membership as specified in the Bylaws of the Association. Voting rights and procedures are to be as specified in the Bylaws of the Association.

ARTICLE V  
POWERS

The authority of the Association is vested in the members as prescribed in the Bylaws of this Association. The Association is empowered to: A) collect and disseminate information; B) conduct public meetings; C) engage in funding and fund-raising activities; and D) promote the purposes of the Association.

ARTICLE IX  
DISTRIBUTION OF PROPERTY ON DISSOLUTION

Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, distribute all the assets of the Corporation consistent with the purposes of the Corporation to such organization or organizations as shall at that time qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, as amended from time to time, in such manner as the Board of Directors shall determine. Any such assets not so distributed shall be distributed by the district court of the county in which the principal office of the Corporation is then located, exclusively for the purposes or to such organizations, as such court shall determine to be consistent with the purposes of the Corporation.
