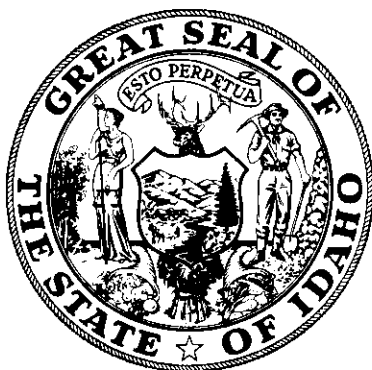

ARTICLES OF INCORPORATION
OF
MINIDOKA COUNTY SPORTSMENS CLUB, INC.

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a corporation under Chapter 3 of Title 30 of the Idaho Code, Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is: Minidoka County Sportsmens Club, Inc.

ARTICLE II

The period of its duration is: Perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are: Prompting sportsmanship; conservation of wildlife resources; promoting hunting and fishing opportunities and areas within Minidoka County and surrounding counties; providing wildlife habitat in Minidoka and surrounding counties; providing facilities and maintaining an area for trap shooting, sponsoring and holding trap shoots and such other and further kindred purposes.

ARTICLE IV

The members of the corporation shall be natural persons who embrace the purposes of the corporation and who shall make application for membership pursuant to the By-Laws of the corpora-

tion. No membership issued by this corporation shall be transferable.

ARTICLE V

The manner in which directors are to be elected is: Directors shall be elected annually at a meeting of the members called for that purpose.

ARTICLE VI
