

**ARTICLES OF INCORPORATION  
OF  
EAGER BEAVER TREE AND FENCE, INC.**

The undersigned, as the incorporators of a corporation under the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation for such corporation:

1. **Name of Corporation.** The name of the corporation is Eager Beaver Tree and Fence, Inc.
2. **Period of Duration.** The period of duration of the corporation is perpetual, unless sooner dissolved by action of the shareholders or by operation of law.
3. **Purpose.** The corporation is organized to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
4. **Shares Authorized.** The corporation shall have the authority to issue, in the aggregate, Ten Thousand (10,000) shares of stock, all of one class, of the par value of One Dollar (\$1.00) per share.
5. **Classes of Stock.** Only one class of stock is to be issued.
6. **Preemptive Rights.** The corporation has no provisions denying preemptive rights to shareholders.
7. **Regulation of Internal Affairs.** The incorporators do not elect to set forth any provisions for the regulation of the internal affairs of the corporation in these Articles.
8. **Registered Agent.** The name and address of the initial registered agent and initial registered office of the corporation are: John M. Thomas, 1223 North Midland, Nampa, Idaho 83651.
9. **Directors.** The number of directors constituting the initial board of directors is **1** (1) STATE. The names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and qualify are: **John M. Thomas** (1) STATE. **10/04/1996** (1) STATE. **19754** (1) STATE. **28227** (1) STATE. **CORP** (1) STATE.


