ARTICLES OF INCORPORATION

of

BANK OF CENTRAL IDAHO

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, being natural persons of full age, citizens of the United States and residents of the State of Idaho, this day have voluntarily associated ourselves for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho and we do hereby certify as follows:

I

NAME

The name of this corporation shall be BANK OF CENTRAL IDAHO.

II

PURPOSE

The purposes for which this corporation is formed are:

a. To engage in and carry on a banking and trust business, as defined in the laws of the State of Idaho, and particularly the "Bank Act" thereof; to conduct the business of receiving money on deposit; to solicit, receive or accept money or its equivalent on deposit as a regular business.

b. To carry on a savings bank business as set forth in Section 26-103, Idaho Code.

c. To receive deposits of money, deal in commercial paper and to make loans thereon; to loan money on real and personal property; to purchase or discount bills, note or other commercial paper; to buy and sell and advertise for purchase or sale such securities as are permissible for an investment of commercial

banks, and, so far as permitted by the laws of the United States, gold and silver bullion, and foreign coins and foreign bills of exchange; to do all things incidental to or comprehended within the authority of a commercial banking business within the laws of the State of Idaho.

d. To do a trust business as defined and permitted by Section 26-105, Idaho Code, and other provisions of the laws of the State of Idaho.

e. To purchase, acquire, hold and convey real estate, to the extent permitted by, and subject to the limitations prescribed in Section 26-609, Idaho Code.

f. To subscribe to the capital stock of and become a member of a federal reserve bank.

III

DURATION

The existence of this corporation shall be perpetual.

IV

REGISTERED OFFICE

The principal place of business and registered office of this corporation shall be at Grangeville, Idaho County, Idaho.

V

STOCK

This corporation is authorized to issue one class of shares of stock, the total number of which is 1,500 with a par value of \$100.00, which stock may be issued by the corporation from time to time as determined by the Board of Directors hereof.

VI

DIRECTORS

The number of directors shall be not less than seven

nor more than eleven, as may be provided by the By-Laws of the corporation.

VII

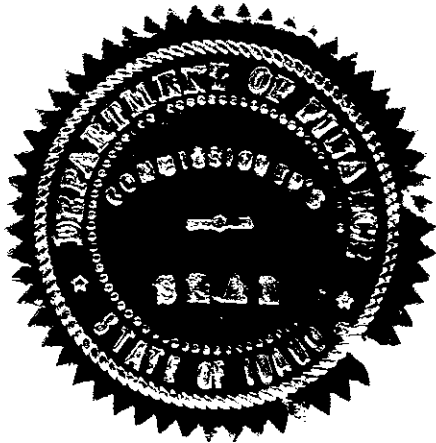


