We, the undersigned, do hereby amend the Articles of Incorporation of Specialized Molding Services Corporation as follows:

(a) Said corporation is presently known as Specialized Molding Services Corporation.

(b) The shareholders, directors and officers of said corporation have agreed to change said name to Protoworx Corporation.

(c) The date this amendment was adopted by the shareholders, board of directors and incorporators is September 3, 1994.


(d) There are a total of 10,000 shares in said corporation. Said shares are owned as follows:
