#### ARTICLES OF INCORPORATION

OF

We, the undersigned, being three or more natural persons of full age, at least two-thirds of whom are citizens of the United States or of its territories or possessions, do hereby voluntarily associate ourselves for the purpose of forming a private corporation under the laws of the State of Idaho.

### ARTICLE I

The name of this corporation is:

CREDIT PROGRAMS AND SERVICES, INC.

#### ARTICIE II

The purposes of the corporation are:

To engage in any Commercial, Industrial, and Agricultural Enterprise calculated or designed to be profitable to this corporation and in conformity with the laws of the State of Idaho;

To generall engage in, do, and perform, any enterprise, act, or vocation that a natural person might or could do or perform;

To engage in the manufacture, sale, purchase, importing, and exporting of merchandise and personal property of all manner and description, to act as agents for the purchase, sale and handling of goods, wares, and merchandise of any and all types and descriptions for the account of the Corporation or as factor, agent, procurer, or otherwise for or on behalf of another;

To buy and sell real property.

#### ARTICLE III

The duration of the Corporation is perpetual.

### ARTICLE IV

The location and post office address of the registered office of the Corporation in the State of Idaho is Pocatello, Bannock County.

# ARTICLE V

The total authorized number of par value shares is 20,000. The aggregate par value of the total authorized number of par value shares is \$50,000.00.

### ARTICLE VI

The stock of the Corporation is divided into 20,000 shares of Common Stock. Each share of stock issued shall be entitled to one vote in the Corporation.
