

**ARTICLES OF AMENDMENT  
to the  
ARTICLES OF INCORPORATION  
of  
MICHAEL S. ENGL FOUNDATION, INC.**

Pursuant to Idaho Code Section 30-3-93, Idaho Nonprofit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** The current name of the corporation is Michael S. Engl Foundation, Inc.

**SECOND:** The corporation has had no members since its incorporation on September 1, 1994.

**THIRD:** The following amendment to the Articles of Incorporation was adopted by all the directors of the corporation on the 27th day of October, 1995, in the manner prescribed by the Idaho Nonprofit Corporation Act.

**FOURTH:** Article I of the Articles of Incorporation is amended in its entirety to read as follows:

The name of the corporation is "MICHAEL S. ENGL FAMILY FOUNDATION, INC."


