WHEREAS, Articles of Incorporation of Riverside Irrigation District Limited, were filed with the Secretary of State of The State of Idaho on April 27, 1894; and

WHEREAS the said Articles of Incorporation provided that the period of existence of said Corporation was for the period of fifty (50) years; and

WHEREAS, the Beard of Directors of saidCorporation called a meeting of the stockholders of said Corporation for January 12, 1952 at Roswell, Canyon County, Idaho; that notice of said meeting was given according to law, and expressly for the purpose of considerating the extension of the life of said Corporation; and

WHEREAS, pursuant to said notice, a meeting of all the stock-holders of said Corporation was held at Roswell, Canyon County, Idaho, on January 12, 1952, said meeting being expressly for considering the subject of extending the life of the Corporation perpetually; that more than two-thirds of the stockholders of said Corporation were present in person or by proxy and voted; that a ballot was cast upon the question whether the Corporation should be extended perpetually, and that the return showed a majority ballot in favor of extending the life of the Corporation perpetually.

wherefore, by majority consent of more than two-thirds of the stockholders of said Corporation, the life of the aforesaid Corporation is hereby extended perpetually, and that the above and foregoing Certificate is made in compliance with Section/30-160/Idaho Code.
