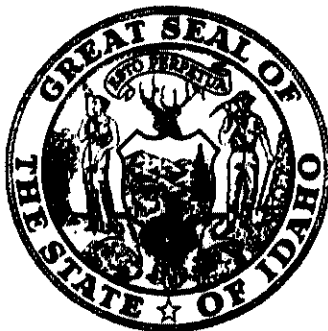
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

TAYLOR APPLICATIONS, INC.

4 The undersigned, acting as an incorporator of a
5 corporation under the Idaho Business Corporation Act, adopts the
6 following Articles of Incorporation for such corporation.

7 1. NAME: The name of the corporation is TAYLOR
8 APPLICATIONS, INC.

9 2. DURATION: The period of the duration of the
10 corporation is perpetual.

11 3. PURPOSE: The purpose or purposes for which the
12 corporation is organized is the transaction of any and all
13 lawful business for which corporations may be incorporated under
14 the Idaho Business Corporation Act. Without limiting the
15 foregoing the corporation shall have as its major purpose the
16 application of fertilizers, pesticides, herbicides and such
17 other agricultural products as may be appropriate and to have
18 applicable regulatory licenses, if any be required, in
19 connection with such applications.

20 4. STOCK: The aggregate number of shares which the
21 corporation shall have authority to issue is 10,000, all of
22 which shall be voting and shall be without par value.

23 5. PRE-EMPTIVE RIGHTS: There are no prohibitions
24 denying pre-emptive rights.

25 6. OFFICE AND AGENT: The address of the initial
26 registered office of the corporation is Star Route, Declo,

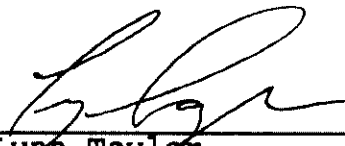
1 Cassia County, Idaho 83323. The name of the initial Registered
