These Articles of Amendment and the following certificate is hereby made and executed pursuant to Section 30-146, Idaho Code, for the purpose of amending the Articles of Incorporation of HokeAir, Inc., an Idaho corporation, and to effect a change of name of said corporation to Helicopters, Inc.

The undersigned, Lloyd Jack Hoke, President of said corporation, and Maude Elaine Hoke, Secretary of said corporation, do hereby respectively certify as follows:

I

That a meeting of all of the stockholders of HokeAir, Inc., an Idaho corporation, was held on September 15, 1966, at 203 Equitable Life Building, Fifth and State Streets, Boise, Idaho, pursuant to call and waiver of notice signed by all of the stockholders and filed in the minute book of the corporation.

II

That at such meeting, the following resolution was presented, and upon motion duly made, seconded and unanimously carried, the same was adopted:

BE IT RESOLVED, That Article I of the Articles of Incorporation of HokeAir, Inc., be amended by deleting the entire first Article and inserting in place thereof, the following:

"ARTICLE I

The name of the corporation is HELICOPTERS, INC."


BE IT FURTHER RESOLVED, That the President and Secretary of the corporation, respectively, be, and they are hereby, authorized to prepare a certificate of this resolution and amendment to the Articles of Incorporation of this corporation and to file the same with the Secretary of State for the State of Idaho, and to do all things necessary in order to duly effect the change of name of this corporation in accordance with this resolution.
