ARTICLES OF INCORPORATION

OF

PERINATAL ASSOCIATES, P.A.

KNOW ALL MEN BY THESE PRESENTS, That William V. Cuthrell, the undersigned, in order to form a corporation for the purposes hereinafter stated, pursuant to the Professional Service Corporation Act of the State of Idaho, as now in effect or as may hereafter be amended, do hereby certify as follows:

ARTICLE I

The name of the corporation is Perinatal Associates, P.A.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

This corporation is organized for the purpose of engaging in the practice of medicine and of transacting all lawful business which this corporation may do under the Professional Service Corporation Act of the State of Idaho.
