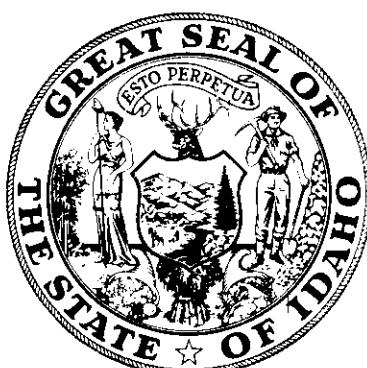

**ARTICLES OF AMENDMENT
OF C V CATTLE CO.**

C V CATTLE CO., a corporation duly organized and existing under and by virtue of the laws of the State of Idaho, hereby submit these Articles of Amendment pursuant to Idaho Code §30-1-61 and certify as follows:

That a resolution was unanimously adopted by the Board of Directors of the C V CATTLE CO. on October 26, 1989, proposing to amend the corporate Articles of Incorporation to increase the aggregate number of shares which the corporation has authority to issue from five hundred (500) to five thousand (5,000).

That said resolution adopted by the Board of Directors was submitted to the shareholders for approval at a special meeting held on October 26, 1989, was voted upon and adopted by the unanimous vote of all six (6) shareholders, thereby amending Article 4 of the Articles of Incorporation of said company so that said Article 4 as amended shall read as follows, to wit:

4. **SHARES AUTHORIZED:** The aggregate number of shares which the corporation shall have authority to issue is five thousand (5,000) shares of no par value common stock.
