ARTICLES OF INCORPORATION

OF

4-U RANCH COMIANY

KNOW ALL MEN BY THESE FRESENTS, That we, the undersigned, Neil R. Barnes, Margaret R. Barnes and A. C. Kiser, each being a natural person of full age, and a citizen of the United States of America, have voluntarily and do hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify, declare and adopt the following articles of incorporation:

Ţ.

The name of this corporation shall be 4-U RANCH COMPANY.

II.

The period of existence and duration of the life of this corporation shall be perpetual.

III.

The location of the registered office of this corporation shall be Indian Vailey, County of Adams, State of Idabo, and the address of the registered office of this corporation shall be Indian Valley, Idaho.

IV.

The nature of the business and the cojects and purposes of this corporation shall be:

To acquire ranch properties and to construct, develop, maintain, operate and control recreational facilities of every kind and nature and to do any act or thing necessary or convenient connected therewith for the purposes herein set forth or ancillary or related thereto including the establishing of rules and regulations for the use and operation of any and all such facilities.

To build, raintain, rent and lease cabins and cabin sites; to build, maintain and operate lodges, retail stores and golf courses.

To engage in the business of farming and raising, feeding and caring for livestock. To enter into, make and terform and carry out contracts of every sort and kind with any person, firm, association or corporation, municipality, body politic, country, territory, district, state and government.

To purchase, hold, seil, assign, transfer, mortgage, pledge or otherwise dispose of chares of the capital stock of, or any bonds, securities or evidence of indebtedness created by, any other comporation or comporations organized under the laws of this state or any other state, country, nation or government, and while the owner thereof to exercise all the rights, powers, and privileges of ownership.

To apply for, secure, acquire by assignment, transfer, furchase, or otherwise, and to exercise, carry out and enjoy any charter, license, power, authority, franchise, concession, rights, or privileges, which any government or authority or any corporation or other public body may be empowered to grant; and to pay for, aid in and contribute toward carrying the same into effect.

To acquire, and pay for in each, stock or bonds of this corporation or otherwise, the good will, rights, essets and property and to undertake or assume the whole or any part of the colligations or liabilities of any person, firm, association, or corporation.

To draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange, and other negotiable or transferable instruments.

In the purchase or acquisition of projecty, business, rights or franchises, or for additional working capital, or for any other object in or about its business or affairs, and without limit as to amount, to incur debt, and to raise, borrow, and secure the payment of money in any lawful manner, including the issue and cale or other disposition of bonds, debentures, obligations, negotiable and transferable instruments and evidences of indebtedness of all kinds, whether secured by mortgage, pledge, deed of trust or otherwise.

To earry on any other business, which may seem to the corporation capable of being conveniently carried on in connection with its business or calculated directly or indirectly to enhance the value or render profitable any of the corporation's projectly or rights.

To do each and everything necessary, suitable, useful or advisable for the accomplishment of any one or more of the objects of said corporation, or which shall,

at any time, appear to be conducive to or expedient for the benefit of said corporation in connection therewith.

To do each and all things set forth herein to the name extent and as fully as natural persons might do or could do in the State of Idaho, and in any other state, country or place.

To purchase, hold, sell and transfer the shares of its own capital stock, provided it shall not use its funds or property for the purchase of its own shares of capital stock when such use would cause any impairment of its capital; and provided further that chares of its own capital stock belonging to it shall not be voted upon directly or indirectly.

To have one or more offices, to carry on all or any of its operations and business and without restriction or limit at to amount, to purchase, or otherwise acquire, to hold, own, to mortgage, sell, convey, lease or otherwise dispose of real and personal property of every class and description in any of the states, districts, territories, dependencies, possessions or colonies of the United States.

The foregoing clauses shall be construed as objects, purposes and powers; and it is hereby expressly provided that any enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this corporation.

The said corporation may perform any part of its business outside the State of Idaho, in the other states, in the District of Columbia, territories or possessions, or dependencies of the United States.

In general, to carry on any other business in connection with the foregoing, and to have and exercise all the lowers conferred by the laws of Idaho upon corporations.

V.

In furtherance, and not in Limitation of the powers conferred by statute, the board of directors is expressly authorized:

To make and alter by-laws of this corporation, to fix the amount to be reserved as working capital over and above its capital stock gaid in, and to authorize and cause to be executed mortgages and liens upon the real and personal property of this corporation.

If the by-laws so provide, to designate two or more of its members to constitute an executive committee, which committee shall for the time being, as provided in said resolution or in the by-laws of the corporation, have and exercise any or all of the

powers of the board of directors in the management of the business and affairs of this corporation, and have power to authorize the seal of this corporation to be affixed to all papers which may require it.

forsuant to the affirmative vote of the holders of at least a majority of the stock issued and outstanding, having voting power, given at a stockholders' meeting duly called for that purpose, or when authorized by the written consent of at least a majority of the holders of the voting stock issued and outstanding, the board of directors shall have power and authority at any meeting to sell, lease or exchange all of the property and assets of this corporation, including its good will and its corporate franchises, upon such terms and conditions as its board of directors deem expediant and for the best interests of the corporation.

This corporation may in its by-laws confer powers upon its directors in addition to the foregoing, and in addition to the powers and authorities expressly conferred upon them by statute.

VI.

The total number of shares which this corporation is authorized to issue is one hundred (160) all of which shall be without nominal or par value. All or any parties of the Capital stock may be issued for each or in payment for real or personal property, water rights, services, or any other right or thing of value, for the uses and purposes of the corporation, and when so issued shall become and be fully paid.

Such shares may be issued by the conjuration from time to time, without action by the stockholders, for such consideration and upon such terms as may be fixed from time to time by the board of directors, and shares so issued, the full consideration for which as so fixed board of directors has been gaid or delivered, shall be deemed fully paid, and no holder of any such shares shall be liable for any further gayment thereon.

VIL.

All shares of this corporation are of the same class and shall have equal voting gower, rights and privileges and none of said shares shall have preferences and/or restrictions.

VIII.

From time to time the capital stock may be increased according to law, and may

be issued in such amounts and proportions as shall be determined by the board of directors, and as may be permitted by law.

IX.
