Articles of Amendment to the Articles of Incorporation of

RESERVED Dodds-Strolberg Insurance Agency, Inc. (An Idaho Corporation)

The Shareholders of Dodds-Strolberg Insurance Agnecy, Inc. (the "Corporation"), at the recommendation of its Board of Directors, have adopted the following Articles of Agneniument, undertilidaho Code Section 30-1-59:

- 1. The Name of the Corporation is: Dodds-Strolberg Insurance Agency, Inc.
- 2. The text of the amendment adopted is as follows:

Amendment Number 1:

ARTICLE I of the original Articles of Incorporation filed and accepted by the State of Idaho Office of Secretary of State on December 23, 1985 (File #80165), is hereby amended and shall hereafter read in its entirety as follows:

The name of the Corporation shall be Strolberg-Leavitt Insurance Agency, Inc.

- 3. The amendments do not provide for an exchange, reclassification or cancellation of issued shares.
 - 4. The above amendment was adopted on May 2, 1994.
 - 5. The amendments were adopted by shareholder action.
 - 6.(a). There were 2,500 issued and outstanding shares of common stock entitled to vote at the time the amendments were adopted. The holders of the 2,500 issued and outstanding shares were indisputably represented at the shareholders meeting where the vote was taken. Common stock is the only class of stock authorized.
 - 6.(b). There were 2,500 votes for the proposed amendments and zero (0) votes against the proposed amendment.
