Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** The name of the corporation is TODD HUNZEKER CHEVROLET, OLDS., BUICK, INC.

**SECOND:** The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on February 19, 1993, in the manner prescribed by the Idaho Business Corporation Act;

Article THIRD was amended to read as follows:

**THIRD:** The purpose or purposes for which the corporation is organized are to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, and to engage in the business of insurance.

**THIRD:** The number of shares of the corporation outstanding at the time of such adoption was 4,000; and the number of shares entitled to vote thereon was 4,000.

**FOURTH:** The number of shares that voted for such amendment was 4,000; and the number of shares that voted against such amendment was zero.


