

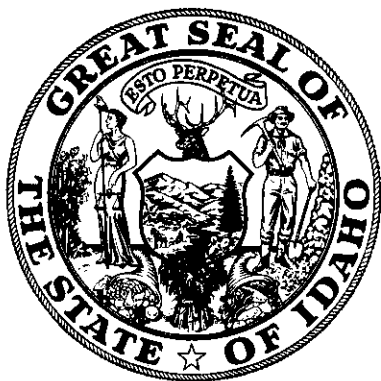
CERTIFICATE OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that I, MICHAEL P. CHRISTENSEN, M. D., who is of legal age, desires to form a corporation, under and pursuant to the laws of the State of Idaho, and does thereby certify:

ARTICLE I:

That the name of this corporation shall be 2205 N. Ironwood Pl., Inc.

ARTICLE II:

That the duration and existence of this corporation shall be perpetual.

ARTICLE III:

That the purposes of this corporation, as formed, are as follows:

To engage in any lawful act or activity for which corporations may be organized under the laws of the State of Idaho.

ARTICLE IV:
