

ARTICLES OF INCORPORATION.

KNOW ALL MEN BY THESE PRESENTS; That we, the undersigned, bona fide residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, And we hereby certify;

Article I.

The name of this corporation shall be

THE WEISER BOARD OF TRADE, LIMITED.

Article II.

The purposes for which this corporation is formed are, to promote the trade, commerce, interests and general welfare of the City of Weiser Idaho and vicinity; To raise funds as contributions to promote the establishment of industries, and other public benefits and improvements at Weiser and vicinity; To guarantee the payment of any bonus, pledge, gift, annuity or other obligation pledged in the support of any enterprise or industry, and to purchase, hold and sell any personal and real estate necessary to carry out the objects herein stated.

Article III.

The place where the principal business of this corporation is to be transacted, is at the office of this corporation, in the City of Weiser County of Washington, State of Idaho.

Article IV.

The term for which this corporation is to exist, is Fifty ( 50 ) years from the 26th. day of June 1901.

Article V.

The number of the Directors of this corporation shall be Seven ( 7 ) and the names of those appointed for the first year are

All residing at Weiser, County of Washington, State of Idaho.

Article VI.

The amount of the Capital Stock of this corporation shall be Ten Thousand Dollars (\$10000.00) divided into One Thousand (1000) Shares of the par value of Ten Dollars (\$10.00) each.
