ARTICLES OF INCORPORATION

OFF

WESTERN AIRCRAFT, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all being citizens of the United States, of legal age, this day having voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, do hereby certify:

ARTICLE I.

11 The name of the corporation shall be "WESTERN AIRCRAFT,
12 INC."

ARTICLE II.

Purposes

20 (b) To establish, own, maintain and generally turn to
21 account transport service and charter service for the transporta-
22 tion of passengers and all other service of a similar character
23 which may from time to time be valid.

24 (c) To own, purchase, construct, lease, operate and dis-
25 pose of hangars, transportation depots, aircraft service stations
26 and agencies and other objects and service of a similar nature
27 which may be necessary, convenient, or useful as an auxiliary to
28 an aircraft business.

29 (d) To own and operate educational institutions for
30 instruction in the construction, operation, maintenance and repair
31 of aircraft; to operate and maintain a flying school and to instruct
32 or provide for instruction in aviation.

5 (f) To own, operate and maintain an aerial dusting and
6 spray service and to buy and sell chemicals used in connection
7 with dusting and spraying of all kinds and nature.

1 any person, firm, association or corporation engaged in the busi-
2 ness so acquired.

3 (k) To borrow money for any purpose of this corporation,
4 without limit as to amount, to issue bonds, debentures, notes or
5 other evidences of indebtedness, secured or unsecured, of this
6 corporation for the moneys so borrowed or in payment for property
7 acquired, or for any other objects or purposes of this corporation,
8 or in connection with its business; to secure payment of such de-
9 bents, notes or other obligations by mortgages or pledges or
10 other liens upon any or all of the property of this corporation
11 wheresoever situated.

12 (l) To carry out all or any part of the foregoing ob-
13 jects or purposes as principal or agent, or otherwise, either alone
14 or in conjunction with any person, association or other corporation
15 and in any part of the world; and in carrying on its business and
16 for the purpose of attaining or furthering any of its objects or
17 purposes, to make and perform such contracts of any kind and des-
18 cription, to do such acts and such things, and to exercise any and
19 all such powers as a natural person could lawfully make, perform,
20 do, or exercise, provided that the same be not inconsistent with
21 the objects or purposes of this corporation, or the statutes of the
22 State of Idaho.

23 (m) To conduct its business in all or any of its branches
24 in the State of Idaho, and in any and all other states, territories,
25 possessions, colonies and dependencies of the United States of
26 America and in the District of Columbia, and in any or all foreign
27 countries, and to have one or more offices within or outside of the
28 State of Idaho.

29 (n) The objects as specified herein shall, except as
30 otherwise expressed, be in no way limited or restricted by reference
31 to or inference from the terms of any other clause or paragraph of
32 these Articles. The objects, purposes and powers specified in each

1 of the clauses or paragraphs in these Articles shall be regarded
2 as independent objects, purposes and powers.

3 The foregoing shall be construed as objects and powers
4 and the enumeration thereof shall not be held to limit or restrain
5 in any manner the general powers now or hereafter conferred on this
6 corporation by the statutes of the State of Idaho.

ARTICLE III.

Duration

9 The period of existence and the duration of the life of
10 this corporation shall be perpetual.

ARTICLE IV.

Place of Business

13 The location and post office address of the registered
14 office of this corporation in the State of Idaho shall be Gooding,
15 County of Gooding, State of Idaho.

ARTICLE V.

Stock

18 This corporation is authorized to issue one class of
19 shares of its capital stock to be designated as common stock; the
20 total number of shares of common stock which this corporation shall
21 be authorized to issue is 500. The aggregate par value of the
22 stock of this corporation shall be \$50,000.00; and the par value of
23 each share of the common capital stock shall be \$100.00.

ARTICLE VI.

Incorporators
