FIRST: The name of the corporation is J & P Construction, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is to provide all types of construction both residential, agricultural and commercial, and all other related business.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) shares, with a par value of \$1.00 per share.

FIFTH: There shall be no provisions denying preemptive rights in these Articles of Incorporation.


