ARTICLES OF INCORPORATION

OF

ELREMKin, INCORPORATED

WE, THE UNDERSIGNED, have this day voluntarily associated ourselves together for the purpose of forming a Corporation for profit under the laws of the State of Idaho, and to that end, do hereby adopt Articles of Incorporation as follows:

I.

The name of the proposed Corporation is "ELREMKin, INCORPORATED."

II.

The purposes for which the Corporation is formed are:

To acquire, take, hold, buy, sell, mortgage, exchange, lease, and otherwise acquire, dispose of and deal in real estate and personal property and any interest therein.

To erect and construct buildings and to dispose of the same.

To make and enter into all types of contracts, agreements, and obligations by or with any person or persons, corporation or corporations, for the purpose of carrying on such business.

To draw, accept, endorse, acquire, and sell negotiable or transferable instruments.

To exercise full power to perform any and all acts connected or arising from or incidental to, and all acts proper or necessary for the purpose of carrying on such business.

III.

The duration of the Corporation is perpetual.

IV.

The location and Post Office address of the registered office of the Corporation in the State of Idaho is the Elder Building, Coeur d'Alene, Idaho.

V.

The total authorized number of shares of capital stock of this Corporation is One Hundred Thousand Dollars, (\$100,000.00), which have a par value of One Hundred Dollars (\$100.00) and shall be divided into one thousand shares.

VI.

The shares of stock are not to be classified and all shares shall be of equal voting power. Said shares of stock are transferable only upon the books of the Corporation under conditions, in the manner and subject to the restrictions set out in these Articles of Incorporation and such other restrictions as may be provided from time to time by the By Laws of this Corporation.
