The undersigned, acting as incorporators of the corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is RISING STAR TRUCKING, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is ten thousand shares (10,000) shares of common stock, with the par value of ten dollars (\$10.00) each for a total capitalization of one hundred thousand dollars (\$100,000.00). All of said stock shall be of one class and shall be common stock.
