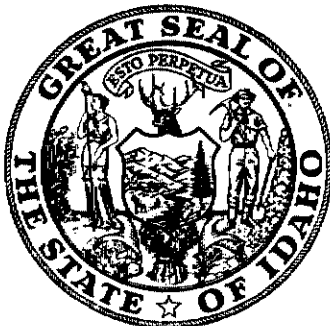

ARTICLES OF INCORPORATION

The undersigned, being a natural citizen of the age of nineteen (19) years or more, a citizen of the United States and a resident of the United States and a resident of the State of Idaho, acting as an incorporator of a corporation hereinafter referred to as the "Corporation" under the provisions of Title 30, Chapter 13, Idaho Code, the Idaho Professional Services Corporation Act, hereinafter referred to as the "Act", adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation is Liljenquist Chiropractic, P.A.

ARTICLE II

The period of duration of the Corporation is perpetual.

ARTICLE III

Purposes and Powers

Section 1. PURPOSES: To engage in the practice of Chiropractic medicine as a professional corporation and to rent, own and operate a medical clinic for the purposes of providing Chiropractic care and treatment; and to own real and personal property, enter into contracts, and engage in any lawful business necessary for the rendering of such professional services; and to do every other act incidental thereto which is not prohibited by the laws of the State of Idaho.

Section 2. STATUTORY POWERS: Subject to any specific written limitations or restrictions imposed by the Act, by other law, or by these Articles of Incorporation, and solely in furtherance of, but not in addition to, the limited Purposes set forth in Section 1 of this Article, the Corporation shall have and exercise all of the powers specified in Section 30-1307, Idaho Code.

ARTICLE IV

Authorized Shares

The amount of the total authorized capital stock of this Corporation is 100 shares without nominal or par value, and which shall be all of the same class. Such stock may be issued from time to time without action by the stockholder, for such consideration as may be fixed from time to time by the Board of Directors, and shares so issued, the full consideration for which has been paid or delivered, shall be deemed fully paid stock and the holder of such shares shall not be liable for any further payment thereon.

ARTICLES OF INCORPORATION - 1

ARTICLE V

Internal Affairs of the Corporation

Section 1. MEETINGS OF SHAREHOLDER: Meeting of the shareholders of the Corporation may be held at such place, either within or without the State of Idaho, as may be provided in the Code of By-Laws. In the absence of any such provisions, all meetings shall be held at the registered office of the Corporation.

Section 2. CODE OF BY-LAWS: The initial Code of By-Laws of the Corporation shall be adopted by its Board of Directors and shall become effective upon ratification by the shareholders. The power to alter, amend, or repeal the Code of By-Laws or to adopt a new Code of By-Laws shall be contained in the Code of By-Laws and the Code of By-Laws may contain any provision for the regulation and management of the affairs of the Corporation not inconsistent with the Act, or these Articles of Incorporation.

Section 3. AMENDMENTS OF ARTICLES OF INCORPORATION: The Corporation reserves the right from time to time to amend, alter, or repeal, or to add any provision to, its Articles of Incorporation, in any manner now or hereafter prescribed or permitted by the provisions of the Act, and any amendment thereto, or by the provisions of any other applicable statute of the State of Idaho and all rights conferred upon shareholders by the Articles of Incorporation, or any amendment thereto, are granted, subject to this reservation.

ARTICLE VI

Address of Registered Office and Agent

REGISTERED OFFICE AND AGENT: The address of the initial registered office of the Corporation is 2181 Overland Avenue, Burley, Idaho 83318. The registered agent at said address is Cody Liljenquist.

ARTICLE VII

Data Respecting Directors

Section 1. INITIAL BOARD OF DIRECTORS: The number of directors may be increased or decreased from time to time by amendment of the Code of By-Laws; but the number of directors shall not be less than one (1) and no decrease shall have the effect or shortening the term of any incumbent director.


