ARTICLES OF INCORPORATION CERTAIN OF STATE

of

MOFFATT, THOMAS, BARRETT & BLANTON, CHARTERED

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, Moffatt, Thomas, Barrett & Blanton, Chartered, has adopted the following Articles of Amendment to its Articles of Incorporation:

Ι

The name of the corporation is Moffatt, Thomas, Barrett & Blanton, Chartered.

II

The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on March 23, 1983, in the manner prescribed by the Idaho Business Corporation Act:

Article IX of the Articles of Incorporation shall be amended to read as follows:

IX.

The capital stock of this corporation shall consist of one thousand two hundred and fifty (1,250) shares of no par, nonassessable, common stock.

III

The number of shares of the corporation outstanding at the time of such adoption was 158 3/4, and the number of shares entitled to vote thereon was 158 3/4.

IV

The number of shares voted for such amendment was 158 3/4, and the number of shares voted against such amendment was 0.

Such amendment does not effect a change in the amount of stated capital.
