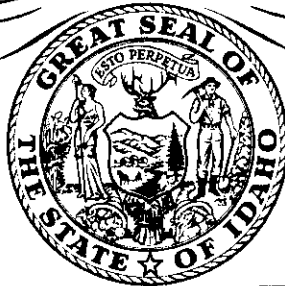

ARTICLES OF INCORPORATION
OF
REED B. ARTHUR, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, REED B. ARTHUR, LAURA MAE ARTHUR, And GERALD ARTHUR, being of full age, and citizens of the United States of America, and actual and bona fide residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

FIRST: That the name of the corporation shall be
REED B. ARTHUR, INC.

SECOND: That the purposes for which said corporation is formed are:

(a) To operate and conduct and carry on any and all agricultural pursuits and livestock;

(b) To operate, conduct and carry on the business of diversified farming and production of any and all kinds of agricultural products; to buy, sell and own any and all kinds of farm machinery and equipment;

(c) To purchase, or otherwise, acquire, own, hold, lease, sell, exchange, assign, transfer, mortgage, pledge or otherwise dispose of, to guarantee, and to invest, trade and deal in and with any and all kinds of real and personal property and livestock for the production of agricultural products and livestock.

(d) To own, hold, lease, sell, convey or otherwise acquire and handle in connection with said livestock and agricultural operations, feed lots and business in connection therewith, to manufacture various kinds of products for the purpose of feeding livestock and the growing and harvesting of agricultural products.

(e) To purchase or otherwise acquire, own, hold, lease, sell, exchange, assign, transfer, mortgage or otherwise dispose of, and to invest, trade and deal in and with real and personal property, and any and all interests therein.

(f) To enter into any kind of contract or agreement, co-operative or profit-sharing plan with its officers or employees that the corporation may deem advantageous or expedient or otherwise to reward or pay such persons for their services as the directors may deem fit.

(g) To borrow money, to issue the corporation notes and other obligations of this corporation from time to time, for any of the objects or purposes of this corporation, and to mortgage, pledge, and hypothecate any or all of its property to secure the payment thereof.

(h) To enter into, make, perform and carry out contracts of every kind and for any lawful purpose, without limit as to amount, with any person, firm, association, corporation, municipality, state, or government, or any subdivision, district or department thereof, that would be for the best benefit of the operation of said business.

(i) To engage in and conduct any and all kinds of manufacturing of products or equipment that maybe beneficial to and used in connection with agricultural and livestock operations as set forth herein.

(j) To do any and all such other acts, things, business or businesses in any manner connected with or necessary, incidental, convenient or auxiliary to any of the objects hereinbefore enumerated, or calculated, directly or indirectly to promote the interest of the said corporation; and in carrying on its purposes, or for the purpose of attaining or furthering any of its business, to do any and all acts and things, and to exercise any and all other powers, which a co-partner or natural person could do or exercise, and which now or hereafter may be authorized by law.

THIRD: That the term of this corporation shall be perpetual.

FOURTH: That the Board of Directors shall consist of Three (3) persons.

FIFTH: That the registered office of the Corporation shall be located at Route 2 , Paul, Minidoka County, Idaho.

SIXTH: The Corporation is authorized to issue only one class of stock, the total number of shares which is Five Hundred (500), par value \$100.00, aggregate value \$50,000.00.

SEVENTH: The Capital Stock of the corporation which has actually been subscribed is Fifty Thousand Dollars (\$50,000.00), and the following are the names, post office addresses and shares:

EIGHTH: That the number of persons above named shall constitute the directors of the corporation until changed by amendment to the by-laws, increasing or decreasing the number of directors, as may be desired, in the manner provided by law.

NINTH: That the Board of Directors shall have the power to amend or change the by-laws by unanimous consent of the members thereof.


