ARTICLES OF INCORPORATION OF ARRICLES OF INCORPORATION OF ARROLD MACHINERY COMPANY. INC.

Arnold Machinery Company, Inc. a corporation of Utah, do hereby certify that, at a Special Meeting of the Stockholders of said Corporation duly called, noticed pursuant to Sec. 16-2-46 U.C.A. 1953 and held at its office in Salt Lake City, Utah, on December 2, 1957, at 3:15 p.m., the Articles of Incorporation and particularly the first paragraph of Article V. thereof was amended by the affirmative vote of stockholders holding more than a majority of the outstanding stock of the Corporation, so as to increase the common capital stock of the corporation from 25,000 shares of the par value of \$10.00 per share to 60,000 shares of the same par value, the number of shares of Preferred stock being unchanged and the preferences and priorities of its holders to be retained as heretofore; said first paragraph of said Article V. being amended so as to read as follows:

## ARTICLE V.

First Paragraph:

The total authorized capital of the Corporation shall be Seven Hundred Thousand (\$700,000) Dollars divided into one thousand shares of preferred stock of the par value of One Hundred (\$100) Dollars per share and Sixty-thousand (60,000) shares of common stock of the par value of Ten (\$10) Dollars per share. Bither class of stock may be issued and sold by the Corporation at such times and for such consideration as the Beard of Directors may determine and as permitted by law.

We further certify that only the first paragraph of said Article V. was amended, all other paragraphs thereof being retained as now constituted.

We further certify that the Articles of Incorporation of Arnold Machinery Company Inc. have been amended in the respect above set out.
