CERTIFICATE OF INCORPORATION.

Washington National Building, Loan and Investment Association

We, the undersigned, each of lawful age, and all citizens of the United States, being desirous of forming a corporation for the purpose of carrying on and conducting the business of aiding and building home-steads, and loaning money to the members of such association or corporation, hereby certify, make, publish and declare as a legal notice to all the world, as follows, to-wit:

- 1. The corporate name of said corporation is hereby declared to be "The Washington National Building, Loan and Investment Association"
- 2. The object for which the corporation is formed, are as follows: To afford its stock-holders a safe, profitable and convenient manner or investing their savings, and to loan funds thus accumulated, together with all interest and profits accruing to the same, to its members only, on approved real estate security, or upon the stock of the association, and to hold and transfer amy real estate acquired by virtue of a sale under any mortgage, judgment or other lien, which said association may have upon such real estate.
  - 3. The capital stock of such association shall be Five Million Dollars, which shall be divided into Fifty thousand shares, of the par value of one hundred dollars each.
  - 4. The term of existence of said association shall be for a period of twenty years, commencing on the 23rd day of September, A. D. one thousand eight hundred and eighty-nine.
    - 5. The principal place of business of this association shall e at the City of Seattle, King County, Washington Territory.
