ARTICLES OF INCORPORATION

OF

ASPEN SECURITIES AND ADVISORY, INC.

The undersigned, acting as Incorporators of a Corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation:

 $\mbox{\it FIRST:}$ The name of the Corporation is ASPEN SECURITIES AND ADVISORY, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the Corporation is organized are: The transaction of any or all lawful business for which the Corporation may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the Corporation shall have authority to issue is 100 shares of no par value common stock

FIFTH: There are no provisions denying pre-emptive rights.

SIXTH: Provisions for the regulations of the internal affairs of the Corporation are set forth in the By-Laws.
