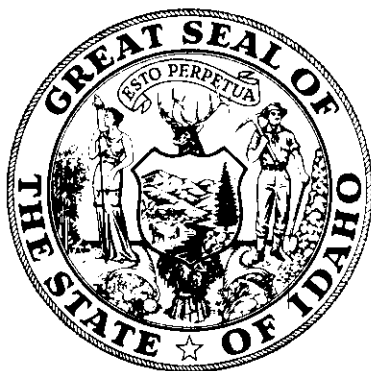


STATE OF IDAHO

The undersigned, being the President and all of the Shareholders of Brady, McDaniel and Matthews, Chartered, a corporation organized under the laws of the State of Idaho, do hereby adopt the following amendment to the Articles of Incorporation of Brady, McDaniel and Matthews, Chartered:


1. Change the name of the corporation from Brady, McDaniel and Matthews, Chartered to: BRADY & McDANIEL, CHARTERED, effective October 7, 1983.

The undersigned further represent that the total number of outstanding shares in said corporation is the sum of 3,000 shares, with 2,250 shares entitled to vote hereupon - 1,500 shares belonging to Michael G. Brady and 750 shares belonging to Terry R. McDaniel - by unanimous vote of 2,250 shares, the above specified amendment is hereby adopted. Such amendment provides for no exchange, reclassification, or cancellation of issued shares nor does it effect a change in the amount of stated capital pursuant to Idaho Code, §30-1-61.




