

Dave Ewy and Norton Graham do hereby certify and declare that they are the President and Secretary, respectively, of Frontier Title, Inc., an Idaho corporation organized and existing under and by virtue of the laws of the State of Idaho. By agreement of the stockholders in lieu of special meeting of the stockholders of Frontier Title, Inc., the Articles of Incorporation of Frontier Title, Inc. were amended to change the name of the Corporation from "Frontier Title, Inc." to "Pioneer Title Company of Kootenai County, Inc." by amending Article I of the Articles of Incorporation to read as follows:

ARTICLE I


The name of the corporation is and shall be Pioneer Title Company of Kootenai County, Inc.


The stockholders of the corporation executed the agreement in lieu of a meeting and adopted the above amendment on the 29 day of December, 1983.






