

ARTICLES OF CONSOLIDATION RECEIVED
SEC. OF STATE

Pursuant to the provisions of Idaho Code Sections
30-1-72, 30-1-73 and 30-1-74 the undersigned non-profit
corporations have adopted the following Articles of Consoli-
dation for the purpose of consolidating them into a new
corporation:

1. The following plan of consolidation was approved
by each of the undersigned corporations:
 - A. That the Apostolic Revival Church of Jerome, Inc.
shall consolidate with the First United Pentecostal
Church, Inc., of Twin Falls, Idaho, and form
a new corporation which shall be called The
Pentecostals of Magic Valley, Inc.
 - B. The memberships held in each respective
corporation shall be converted to memberships
in the new corporation without change in any
rights, liabilities duties or obligations of
the members.
 - C. With respect to the new corporation, and
pursuant to Idaho Code Section 30-1-72(d)
the Articles of Incorporation for said new
corporation shall be as provided in attached
Exhibit "A".
2. As to each of the undersigned corporations,

the plan of consolidation was adopted in the following manner:

A. The plan of consolidation was adopted by the Apostolic Revival Church of Jerome, Inc., at a meeting of its members held on May 4, 1986, at which a quorum was present. The plan of consolidation was approved by 24 members and was opposed by one member.

B. The plan of consolidation was adopted by the First United Pentecostal Church, Inc., of Twin Falls Idaho, at a meeting of its members held on May 4, 1986, at which a quorum was present. The plan of consolidation was approved by 12 members and was opposed by zero members.

3. The number of members in the Apostolic Revival Church of Jerome, Inc. is 31 and the number of members in the First United Pentecostal Church, Inc., of Twin Falls, Idaho, is 15.

4. The manner of the adoption of the plan of consolidation and the vote by which it was adopted constitute full legal compliance with the provisions of the Idaho Code and with the Articles of Incorporation and By-Laws of the undersigned corporations.

5. The effective date of the consolidation is
October 29, 1986.




EXHIBIT "A"

ARTICLES OF INCORPORATION OF THE PENTECOSTALS OF
MAGIC VALLEY, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned residents of the State of Idaho and Members of the Pentecostal Church, in accordance with the rules of said religious society, namely, the Pentecostal Church and by virtue of the laws of the State of Idaho, do hereby associate ourselves together for the purpose of forming a non-profit corporation and do hereby certify as follows:

ARTICLE I

1. The name of the corporation shall be The Pentecostals of Magic Valley, Inc.
2. The corporation's purposes are:
 - A. To establish a community church in Twin Falls and Jerome Counties, State of Idaho.
 - B. To establish in connection therewith suitable and customary organizations for the purposes of public worship and religious training according to the rules and disciplines of the Pentecostal Church.
 - C. To bargain for, purchase, hold and/or depose of any and all real and personal property necessary for the carrying on of all church functions; to build, and/or erect structures on its real estate holdings; to take charge of all

church buildings, estates and property and the affairs of the temporalities thereof.

ARTICLE II.

This corporation shall be a non-profit corporation pursuant to Idaho Code Section 30-301 through 30-332.

ARTICLE III.

This corporation is to have perpetual existence.

ARTICLE IV.

This corporation shall be composed of members and shall have no capitol stock or shares of stock.

ARTICLE V.

The location and street address of the corporation's registered office in this state shall be 126 First Avenue West, Jerome, Idaho. That V. L. Bishop shall be the registered agent, whose address is 126 First Avenue West, Jerome, Idaho.

ARTICLE VI.
