

## CERTIFICATE OF OWNERSHIP AND MERGER MERGING TUNGSTEN MINING CORPORATION INTO HOWE SOUND COMPANY

HOWE SOUND COMPANY, a corporation organized and existing under the laws of Delaware, DOES HEREBY CERTIFY:

on the 30th day of June, 1958, pursuant to the General Corporation Law of the State of Delaware, by an Agreement of Consolidation between Howe Sound Company, a Maine corporation, and Haile Mines, Inc., a Delaware corporation.

SECOND: That this corporation owns all of the outstanding shares of the stock of Tungsten Mining Corporation, a corporation incorporated on the 19th day of April, 1945, pursuant to the General Corporation Law of the State of Delaware.

THIRD: That this corporation, by the following resolutions of its Board of Directors, duly adopted at a meeting held on the 5th day of March, 1964, determined to merge into itself said Tungsten Mining Corporation:

RESOLVED that this corporation merge into itself Tungsten Mining Corporation, its wholly-owned subsidiary, and assume all the obligations of Tungsten Mining Corporation.

RESOLVED that the President, Vice President-Finance and Secretary of this corporation be and each is authorized and directed to make and execute, under the corporate seal of this corporation, a Certificate of Ownership and Merger setting forth a copy of these resolutions to merge into itself Tungsten Mining Corporation and to assume its obligations, and the date of adoption thereof, and to cause such certificate to be filed, in the manner prescribed by law, and to do all acts and things whatsoever, whether within or without the State of Delaware, which any one of them deems to be necessary or proper to effect said merger.
