**AMENDED ARTICLES OF INCORPORATION
OF
MILLER STAUFFER ARCHITECTS, P.A.**

The undersigned, each of whom is duly licensed to practice the profession of architecture in Idaho, desire to amend the Articles of Incorporation of the professional corporation formed for the purpose of rendering architectural services pursuant to Idaho Code Title 30, Chapter 13 on October 2, 1992, and adopt the following amended articles of incorporation for the corporation:

ARTICLE ONE. NAME

The name of the corporation shall be Miller Stauffer Architects, P.A.

ARTICLE TWO. PURPOSES AND POWERS

The purposes for which this corporation is formed are:

1. To engage in the professional practice of architecture; to investigate, evaluate, plan, and design the construction or erection of buildings, structures, and other projects; to provide professional advice on any such construction; and to supervise and inspect such construction for the purpose of assuring conformity with plans and specifications;
2. To own property, enter into contracts, and carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objectives of the corporation; and
3. To do everything necessary, proper, or convenient for the accomplishment of any of the purposes set forth in articles, and to do every other act incidental to such purposes that is not prohibited by the laws of Idaho or by the provisions of articles of incorporation.

The name shall be Miller Stauffer Architects, P.A.

The corporation shall carry out the above professional purposes only through duly licensed or otherwise lawfully authorized architects.

ARTICLE THREE. PRINCIPAL OFFICE

The post office address of the principal office of the corporation in Idaho is 601 E. Front Avenue, Suite 201, Coeur d'Alene, ID 83814.

ARTICLE FOUR. MANAGEMENT OF CORPORATION BY SHAREHOLDERS

Pursuant to Idaho Code § 30-1-732(1)(a), the shareholders of the corporation hereby agree that the business of the corporation shall be managed by the shareholders of the corporation. Any action required or permitted by Idaho law to be taken by the directors of a corporation may be taken by act of the shareholders of this corporation as provided in these bylaws. This provision shall remain effective until amended by the shareholders.

ARTICLE FIVE. CAPITALIZATION

The aggregate number of shares of stock that the corporation is authorized to issue is 1,100 shares, which shares shall be common stock having no par value. Stock shall be issued only to persons who are licensed to practice architecture in Idaho.

ARTICLE EIGHT. DURATION

The duration of the corporation shall be perpetual.


ARTICLE NINE. AMENDMENTS

These articles may be amended, repealed, added to, or new bylaws may be adopted, by majority vote or written assent of shareholders entitled to exercise a majority of the voting power.




