

ARTICLE OF INCORPORATION

OF

DAHLQUIST ELECTRIC, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST : The name of the corporation is Dahlquist Electric, Inc.

SECOND : The period of its duration is perpetual.

THIRD : The purpose or purposes for which the corporation is organized are: Electrical construction and maintenance together with the transaction of all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, Section 30-1-3.

FORTH : The aggregate number of shares which the corporation shall have authority to issue is 50,000 thousand shares of \$1.00 par value common stock.

FIFTH : Shareholders shall have full pre-emptive rights as to issuance of common stock.

SIXTH : Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the By-Laws of the corporation, including provision for restriction on transfer of shares, as provided in Idaho Business Corporation Act, Section 30-1-23A.


