ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF F & J SHEEP AND HAY, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is F & J Sheep and Hay, Inc.

SECOND: The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on December 7, 1992, in the manner prescribed by the Idaho Business Corporation Act:

1. Article V is hereby amended and restated to read as follows:

٧.

The capital stock of the corporation shall be 200 shares of common stock, with no par value. The capital stock of the corporation shall not be assessable.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 100; and the number of shares entitled to vote thereon was 100.

FOURTH: The number of shares voted for such amendment was 60; the number of shares voted against such amendment was 0. The number of shares not voted by reasons of the shareholders not being present was 40.

FIFTH: The amendment does not affect any exchange, reclassification or cancellation of issued shares.

SIXTH: The amendment does not affect a change in the amount of stated capital.
