

ARTICLES OF INCORPORATION

JUNKUNC SAFE & LOCK COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS:-

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho;

AND WE HEREBY CERTIFY:-

FIRST: That the name or title of said Corporation shall be JUNKUNC SAFE & LOCK COMPANY, LIMITED.

SECOND: That the purposes, rights and powers for which the Junkunc Safe & Lock Company, Limited, is organized is to manufacture, sell and otherwise deal in locks *of* all kinds within the United States of America. *of*

To buy, sell and otherwise deal in said locks and all materials of every kind and description necessary to the construction thereof. *To buy, sell and lease patents and patent rights*

That it shall have the right and power to purchase, lease, rent or sell or otherwise deal in any real estate or personal property it may need and require for the proper and economical conduct of its business and shall lease, rent, sell, convey and transfer any such real estate or personal property at pleasure. *To manufacture articles of all kinds.*

That it shall have the power to borrow money and incur indebtedness to such an extent as the Board of Directors may determine and shall issue notes, bonds, obligations, debentures or contracts as evidence of such indebtedness and shall have power to secure said notes, bonds, obligations or other evidences of indebtedness by hypothecating any securities it may own or to execute bills of sale, mortgages or deeds of trust on any property either real or personal, that it may own.

That it shall have the power to make and enter into contracts and enforce the same; to sue and be sued in any Court as a natural person; to make and use a common seal and alter the same.

THIRD: That the principal place of business and the principal office of the company, shall be in Mackay, Custer County, State of Idaho.

FOURTH: That the term for which this corporation is to exist is fifty (50) years from and after the date of its incorporation.
