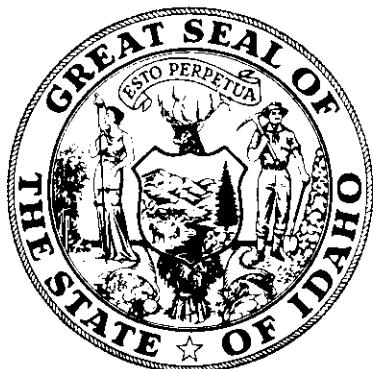

ARTICLES OF INCORPORATION  
OF  
KWIK STOP, INC.

The undersigned, acting as incorporator, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, does hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be Kwik Stop, Inc.

ARTICLE II

The purposes for which said corporation is formed are:

A. To operate and conduct a gas station and convenience store business.

B. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation is to have perpetual existence.

ARTICLE IV

The address of the Corporation's initial registered office shall be 731 Brandon, County of Bonneville, City of Idaho Falls, State of Idaho and the name of its initial registered agent at such address is Jeffry O. Krantz.

ARTICLE V

The capital stock of the Corporation shall be one hundred (100) shares of common stock, without par value. The capital stock of the Corporation shall not be assessable.

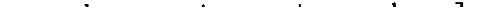
