ARTICLES OF INCORPORATION OF BOISE BIBLE COLLEGE, INC. A NON-PROFIT CORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned members of the:

BOISE BIBLE COLLEGE 8695 Marigold Street Boise, Idaho 83702

all being over the age of twenty-one years and pursuant to the express desires and direction of the membership of said organization, do hereby, under and by virtue of the laws of the State of Idaho, and particularly the provisions of Title 30, Chapter 11, Idaho Code, associate ourselves together for the purpose of forming a non-profit religious, charitable, educational and Christian corporation, and for that purpose do certify as follows:

I.

The name of this corporation shall be:

BOISE BIBLE COLLEGE, INC.

which, since the year 1945, has continuously operated as an educational arm of the First Church of Christ, 1723 Eastman, Boise, Idaho, in an unincorporated form, under the name of Boise Bible College.

II.

This Corporation shall have perpetual existence.

III.

The location and post office address of the registered office of this Corporation shall be:

8695 Marigold Street Boise, Idaho 83702,

but nothing herein contained shall prohibit the change of the registered office of this corporation to a different location in the future.

IV.

This Corporation is not organized for pecuniary profit and it shall not have or issue capital stock, but shall be supported by gifts, bequests, contributions and benefits as may be received. Membership in the Corporation shall not entitle any person to any

interest whatsoever in the assets of the Corporation, but only to participate in the management of the affairs of the Corporation through meetings of the members legally called, and no part of the receipts or income of said Corporation shall inure to the benefit of, or be distributable to any individual member, members or officers of the Corporation, other than for the furtherance of the objects and purposes of the Corporation.

The private property of the members of the Board of Trustees of this corporation shall not be subject to the payment of the corporate debts of the corporation.

This college, as incorporated, shall uphold the standards of the Church as revealed in the New Testament Scriptures; shall contend for the inspiration of the Scriptures and the diety of Christ, (which includes the Virgin Birth, His miraculous life, the Blood Atonement, His Bodily Resurrection from the grave, His Ascension into Heaven and His personal coming again); shall teach the plan of salvation as recorded in the Book of Acts; shall contend for the restoration of the early church, in life, teaching, name, organization and purpose. The general nature of its business shall be to conduct Christian Education in training students in various facets of the ministry. The school will maintain an evangelistic and benevolent emphasis.

The Corporation, through its Board of Trustees, shall have power to confer such scholastic degrees as are usually conferred by institutions of higher learning.

This corporation is not an auxiliary of, or subordinate to, any district, state or national board, or any other form of ecclesiastical system or any other corporation or association, but is free and autonomous in all its transactions and must retain that status forever.

Matters pertaining to this corporation shall not be judged by what other like corporations might think or do.

To achieve the foregoing stated objects and purposes, this corporation shall have power to adopt and establish a constitution

and by-laws and make all rules and regulations deemed necessary and expedient for the management of its affairs, in accordance with law and not inconsistent with these Articles of Incorporation.

VI.

In the carrying out of the foregoing objects of this corporation, it shall have all such powers as are inherent in or given to such corporations by the laws of the State of Idaho, including, but in no-wise limited to the following:

To sue or be sued in its corporate name, and in such name to acquire or receive by purchase, gift, grant, devise or bequest, any property, real, personal or mixed, and the same to hold, sell, transfer, mortgage, convey, loan, let or otherwise use in accordance with the law, custom and discipline of said organization; to hold title to real property, and to construct and erect buildings and facilities thereon for the purpose of carrying out the general purposes of the corporation; to borrow money, to issue bonds, debentures, notes and other obligations of this corporation from time to time, for any of the objects or purposes of this corporation, and to mortgage, pledge, hypothecate or convey in trust, any or all of its property, to secure the payment thereof; to take, receive, hold and disburse donations, and contributions of money and property, bequests and legacies; to further the purposes herein avowed and set forth, by means of written or spoken word, picture, television, radio or otherwise, and to own and operate printing press, radio, television and other apparatus and devices for conveying thought, and the giving expression of thought and of particular things, and to do any and all things lawfully to be done to further the herein avowed and declared purposes of the corporation; to take charge of the buildings, estate and property of the corporation, and the affairs of the temporalities thereof; to have a common seal and to do all things useful and necessary to be done to further efficient and businesslike management thereof.

VII.

The membership and management of this corporation shall

be vested in a Board of Trustees composed of not less than twelve nor more than sixteen members besides members ex-officio. At the first annual meeting of the corporation to be held on such day as hereafter may be fixed by the by-laws, said Board shall elect not less than three nor more than four Trustees to serve for a term of four years, and annually thereafter, there shall be elected not less than three nor more than four Trustees, so that the Board shall regularly consist of not less than twelve nor more than sixteen members besides ex-officio members. The Trustees may succeed themselves one four year term.

The President of the college and the Academic Dean shall be ex-officio members of the Board of Trustees and the Board of Trustees may appoint such other ex-officio members as, from time to time, it shall deem necessary and proper.

#### VIII.

No person shall ever be elected or serve as a teacher in the college or as a Trustee who is not in accord with the policy and doctrinal position of the corporation. Any Trustee, teacher, or other official of Boise Bible College, Inc. who shall be found out of harmony in any way with the policy and doctrinal position of the corporation, upon a hearing conducted before the Board of Trustees at a meeting called for this purpose, at which meeting the person so accused shall have the right to appear and defend himself, shall be no longer a part of Boise Bible College, Inc.

There will be no discrimination made for a faculty member or a student making application for admittance to Boise Bible College, Inc. because of race, color or sex.

IX.

Upon dissolution of the corporation, the Board of Trustees shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or

scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c)(3) of the Internal Revenue Code of 1954, or the corresponding provision of any future United States Internal Revenue law, as the Board of Trustees may determine. However, if at the time of such dissolution, the Christian Children's Home, Inc., Boise, Idaho is in existence, all such assets as aforesaid, shall go to it, as said organization is qualified to receive such assets under the provisions of the Internal Revenue Code and has identical policy and doctrinal positions as those held by Boise Bible College, Inc.
