ARTICLES OF INCORPORATION

OF

WILDER COMMUNITY BUILDING ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all residents of the State of Idaho, do hereby voluntarily associate ourselves together for the purpose of forming and organizing a non-profit, benevolent and charitable organization under and by virtue of the provisions of Chapter 11, Title 30 of the Idaho Code, and hereby make, subscribe and execute the following Articles of Incorporation of said association, and we do hereby certify:

ARTICLE I.

NAME

That the name of this corporation is: WILDER COMMUNITY BUILDING ASSOCIATION, INC.

ARTICLE II.

PURPOSES AND POWERS

This corporation is a non-profit organization and is formed for benevolent and charitable purposes and especially as follows:

To build, erect, maintain, equip, manage and operate a community civic building or buildings to be used as a meeting place for civic clubs, service organizations and public meetings, and to that end adopt and establish by-laws and make all rules and regulations deemed necessary and expedient for the management of its affairs in accordance with law, and not inconsistent with these Articles of Incorporation; and to take, manage and hold and dispose of property, real and personal of said corporation.

ARTICLE III.

PLACE OF BUSINESS

That the principal place of business of this corporation shall be in the City of Wilder, County of Canyon, State of Idaho.

ARTICLE IV.

TERM OF EXISTENCE

The time for which said corporation shall be created shall be perpetual.

ARTICLE V.

CAPITAL STOCK

This corporation does not have and shall not have any capital stock, and neither shall it issue to its members certificates representing capital stock, and this corporation shall not be operated for a pecuniary profit.

ARTICLE VI.

DIRECTORS

The number of directors of this corporation shall be five and the term of office, qualifications of directors and manner of election shall be provided for in the By-Laws.
