That we, G. E. Sparks, A. M. Sparks, and H. C. Sparks, have this day voluntarily associated themselves together for the purpose of forming, and we do hereby form and agree to become a corporation under and by virtue of the ^{Laws of the} State of Washington; and for such purposes ~~we~~ we do hereby certify:

I, That the name of said corporation is Sparks Brothers.

II, That the object and purposes ~~for~~ for which this corporation is formed are as follows. To-wit:-

(A) To carry on a real estate business, by buying, selling, conveying, mortgaging, contracting for leasing, and improving real estate and in other ways deal in land, in its own name and for itself, and as agent for other persons and other corporations, receiving therefor a commission or other compensation.

(B) To loan money for itself taking security therefor in its own name, and for other corporations, persons, and loan companies on commission or other compensation.

(C) To take, hold, purchase, sell, assign, hypothecate, release, and otherwise acquire, dispose of, and deal in mortgages, and other ~~liens~~ ^{liens} on real estate or personal property, and bills, bonds, notes, stocks, warrants of all kinds, and other negotiable paper and evidence of debt, and accounts and choses in action, for itself and in its corporate name, and as agents for other corporations and persons receiving therefor a commission thereon or other compensation.

(D) To buy, sell, mortgage, convey, contract for, and otherwise acquire and dispose of goods, wares, merchandise, grains, live stock, and all other kinds of chattel property for itself and in its corporate name, and as agents for other corporations and persons.

(E) To act as agent ^{the} ~~of~~ ^{of} other corporations and persons in making investments of all and every kind, in collecting notes, bill and accounts, and in transacting ^{business} of all and every kind.

(F) To act as agents ~~for~~ and underwriters for fire, marine, and life insurance companies and corporations.

(G) To borrow money for all or any of the purposes herein mentioned upon its real estate ^{and} ~~or~~ personal property, and its secured and unsecured evidences of debt; and to do and perform any and all of the acts and things mentioned, and carry on the business aforesaid in the State of Washington, and in any other state or territory ⁱⁿ ~~of~~ the United States.

III. That the amount of capital stock of this corporation shall be ten-thousand Dollars, and shall be divided into two-hundred shares of the par value of fifty Dollars each.

IV. That the term for which this corporation is to exist is fifty years from and after the date of ~~the~~ its incorporation.
