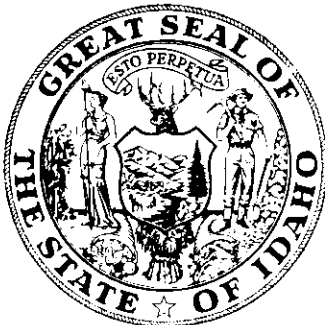

The undersigned, as the President and Secretary
the above corporation, adopt the following amendment to the
Articles of Incorporation of such corporation as follows:

ARTICLE 1

Name

The current name of the corporation is LOCAL 3-364
INTERNATIONAL WOODWORKERS OF AMERICA AFFILIATED WITH A.F.L.-C.I.O.,
INC.

ARTICLE 2

Amendment Adopted

The name of the corporation is hereby amended to
WOODWORKERS LOCAL W364, INTERNATIONAL ASSOCIATION OF MACHINISTS
AND AEROSPACE WORKERS, AFFILIATED WITH A.F.L.-C.I.O., INC.

ARTICLE 3

Date of Adoption of Amendment

The amendment to change the name of all local
organizations was suggested by the International Woodworkers
Association at its annual meeting on January 23 and 24, 1994 in
Portland, Oregon. That the amendment was adopted by the Board
of Directors of the above corporation and by a majority of its
members at a meeting duly called on the 13th day of March,
1994. That following a vote by all local organizations of the
International Woodworkers Association on the amendment, the
International Woodworkers Association directed that all local

organizations, including this corporation, by resolution duly adopted, change the name on such basis effective May 1, 1994.


ARTICLE 4

Shares Authorized to Vote


That under Article VII of the Articles of Incorporation of Local 3-364 International Woodworkers of America Affiliated with A.F.L.-C.I.O., Inc., formerly known as Local 10-364, International woodworkers of American Affiliated With The A.F.L.-C.I.O., Inc., the corporation did not have nor issue any capital stock whatever.

We, the undersigned, for the purpose of amending the Articles of Incorporation dated the 18th day of November, 1957 and filed with the Secretary of State on the 21st day of November, 1957, as amended by Amendment of Articles of Incorporation dated October 9, 1970 and filed with the Secretary of State on the 12th day of October, 1970, do make, file and record these Articles of Amendment.
