## ARTICLES OF INCORPORATION

#### KNOW ALL MEN BY THESE PRESENTS:

That I, the undersigned, natural person of full age, citizen and resident of the United States of America, have this day voluntarily associated myself for the purpose of forming a professional corporation under the laws of the State of Idaho, and do hereby certify as follows:

#### ARTICLE I.

The name of the corporation shall be:

DAVID W. THOMPSON, P.A.

#### ARTICLE II.

That subject to dissolution in the manner provided by law, the duration of this corporation shall be perpetual.

#### ARTICLE III.

The corporation formed herein shall be for the sole purpose of practicing law.

#### ARTICLE IV.

The total authorized capital stock of this corporation shall be one hundred thousand (100,000) shares of common stock with no par value. Shares of stock of this corporation shall not be transferred or sold until said sale shall be approved by the board of directors of the corporation and the By-laws of the corporation shall provide the method for such approval.

#### ARTICLE V.

That the principal place of business, registered office and the location and the post office address of the registered office of said professional corporation shall be 414 N. Lincoln, Suite 4, Jerome, County of Jerome, State of Idaho, and David W. Thompson shall be the registered agent at such address.

#### ARTICLE VI.

That the number of the Directors of said corporation shall be one (1) at its inception and shall not be less than 1 nor more than 8, which number of directors shall be fixed by the Bylaws of the corporation. The names and addresses of the initial members of the Board of Directors is as follows:

#### ARTICLE IX.

The number, qualifications, term of office, manner of election, and powers and duties of directors shall be fixed and may be altered from time to time as may be provided in the By-laws.

#### ARTICLE X.

The private property of the stockholders shall not be subject to or liable for the payment of corporate debts to any extent whatever.

### ARTICLE XI.

By-laws shall be adopted by the directors and when so adopted may thereafter by repealed, amended or new By-laws adopted by the directors by two-thirds (2/3) vote of the directors or may be repealed, amended or new By-laws adopted by a two-thirds (2/3) vote of the outstanding stock of the corporation.

#### ARTICLE XII.

The corporation shall have the power to purchase or otherwise acquire, hold and reissue its own stock, and to buy, acquire, deal in and transfer shares of capital stock, bonds, debentures and other securities issued or created by any other corporation, cooperative marketing or purchasing association.

#### ARTICLE XIII.

The corporation reserves the right to amend, alter, change, or repeal any provision contained in these Articles of Incorporation in the manner now or hereafter provided by law, and all rights conferred on stockholders are granted subject to this reservation.
