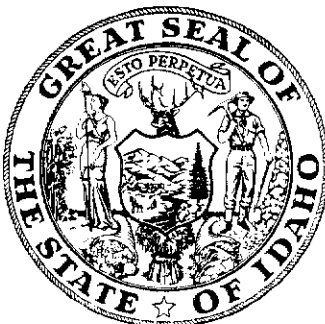

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, Perma Tubes, Inc. has adopted the following Articles of Amendment to its Articles of Incorporation:

I

The name of the corporation is Perma Tubes, Inc.

II

The following amendment of the Articles of Incorporation was adopted by the sole shareholder and directors of the corporation on April 28, 1995, in the manner prescribed by the Idaho Business Corporation Act:

RESOLVED, that Article I. of the Articles of Incorporation of the corporation be amended to read as follows:

I.

The name of the corporation shall be Perma Tubes and Cores Ltd.

III

The number of shares of the corporation outstanding at the time of such adoption was one, and the number of shares entitled to vote thereon was one.

IV


The number of shares voted for such amendment was one, and the number of shares voted against such amendment was 0.

V

Such amendment does not effect a change in the amount of stated capital of the corporation.



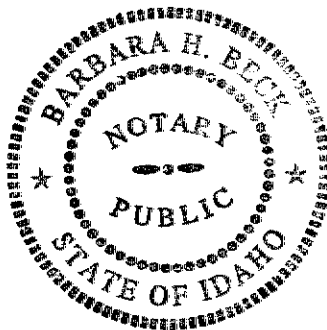
