- 1. The name of the Corporation is VARDEN STUDIOS, INC
- 2. The Certificate of Incorporation was filed by the Department of State on July 6, 1935 under the name of GOLD. TONE STUDIOS, INC.
- 3. On November 10, 1950, the Certificate of Change of Name of this Corporation from GOLD TONE STUDIOS, INC. to VARDEN STUDIOS, INC. was filed with the Department of State.

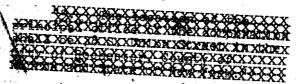
