CERTIFICATE OF INCORPORATION

I, JAS. H. YOUNG, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

BONNERS GOLF COURSE, INCORPORATED

was filed in the office of the Secretary of State on the **nineteenth** day of **October** A. D. One Thousand Nine Hundred **Fifty-nine** and is duly recorded on Film No. **109** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and Sections 30-1001 to 30-1005, inclusive, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at **Bonnere Ferry,** in the County of **Boundary,** and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION OF
BONNERS GOLF COURSE, INC.

KNOW ALL MEN BY THESE PRESENTS: That we whose names are here -
by affixed, all of whom are bonafide residents and full-age citizens
of the United States of American, do under and in pursuance of I.C.
30-1001 et seq., of the Idaho Code as amended, and general corp-
oration laws of said State hereby organize, constitute and associate
ourselves and such other persons as may hereafter become associated
with us, in accordance with theseArticles, into a body politic, and
corporate for the purposes hereinafter set forth, and to that end we
execute these Articles of Incorporation, and hereby certify, set
forth and declare as follows:

I.

NAME

The name of the proposed corporation is BONNERS GOLF COURSE, INCORP-
ORATED.

II.

PURPOSES

The purposes of the corporation are as follows:

To be a benevolent corporation for the welfare of the general
public.

To derive no revenue of any kind from any real or personal prop-
erty owned or being purchased or leased by this corporation; or from
the use thereof.

To engage in the operation of any enterprises calculated or
designed to provide for recreational facilities for the general
public so long as in conformance with the other purposes herein enum-
erated.

To generally engage in, do, and perform any enterprise, act, or
vocation that a natural person might or could do or perform so long
as in conformance with the other purpose herein enumerated.

To engage in the business of buying, acquiring, giving, owning, leasing, transferring, encumbering, and generally dealing in real and personal property so long as in conformance with the other purposes herein enumerated.

To permit any person of the general public to make use of the property of the corporation for recreational purposes in the manner prescribed by the corporation, reserving to the corporation the right to require physical examinations, waiver of liability claims by the individual against the corporation, and such other requirements deemed necessary from time to time by the Board of Directors for the protection of the corporation; including the right to exclude such person or persons whose conduct or intended conduct is or will be detrimental to the purposes of this corporation, and also reserving unto the corporation the right to determine what programs any property of the corporation shall be used for, and in general to have full control and authority of any and all sort over all the property of the corporation.

The purposes herein enumerated shall be construed both as purpose and powers and shall be in no wise limited or restricted by reference to, or inference from, the terms of any other clause in this or any other article, but the purposes and powers specified in each of the clauses herein shall be regarded as independent purposes and powers, and the enumeration of specific purposes and powers shall not be construed to limit or restrict in any manner the meaning of general terms or of the general powers of the corporation, nor shall the expression of one thing be deemed to exclude another, although it be of like nature unexpressed; provided, however; nothing in this paragraph shall be construed as allowing this corporation to receive revenue from its real or personal property.

To do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things incidental or appurtenant to or growing out of or connected with the aforesaid objects or purposes or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized; and also so long as in conformance with the other purpose herein enumerated.

III.

The duration of the corporation is perpetual.

IV.

The location is in the Village of Bonners Ferry, Boundary County, Idaho; and the postoffice address of the registered office of the corporation in the State of Idaho is Bonners Ferry, Idaho.

V.

Membership Certificates shall cost Fifty and no/100(\$50.00) Dollars. Any person can purchase more than one such certificate, but no person shall be entitled to more than one vote regardless of the number of membership certificates he has.

VI.
DIRECTORS


The corporate powers of this corporation shall be vested in a Board of five (5) Directors, to be elected as provided in the By-Laws of this corporation. To be a Director, a person must be a certificate holder. The powers and duties of the officers of this corporation shall be as prescribed in the By-Laws.






