ARTICLES OF INCORPORATION
OF
MAGIC VALLEY MARKETING, INC.

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. The name of the corporation is MAGIC VALLEY MARKETING, INC.
2. The period of its duration is perpetual.
3. Its purpose is to market beans and other agricultural products and such other business not forbidden by law.
4. The corporation shall have authority to issue fifty (50) shares of common stock, all of one class, of no par value.
