ARTICLES OF INCORPORATION

The undersigned hereby states the following to form a professional service corporation under the laws of the state of Idaho.

The name of the corporation is "RHONDA KAY COONSE, P.A."

The corporation shall exist only so long as each and every shareholder is qualified under Idaho Code §§ 30-1309 and 30-1309A. Only those individuals or entities who are licensed, and whose license is in goodstanding, to practice law in the state of Idaho shall be shareholders in the corporation.

The purpose of the corporation is the professional practice of administering anesthesia.

The corporation shall have the authority to issue Ten Thousand (10,000) shares of its common stock with a par value of One Dollar (1.00) each. Such stock shall not be assessable for any purpose. No common stock of the corporation shall be transferable, whether by purchase or gift, to any person, persons, entity, or association of whatever kind, who is not currently licensed, and whose license is in goodstanding, to practice law in the state of Idaho. Shareholders shall not have preemptive rights.
